I have not been convicted of a felony offense under Act 64-1972 (relating to the controlled substance, drug device and cosmetic act) committed within the past five years.

I understand that I may and/or must be dismissed if I am named as a perpetrator of a founded report of child abuse within the past five (5) years or have been convicted of any crime requiring dismissal by law, including but not limited to those listed above.

I understand that my employment may be terminated if I have been named as the perpetrator of an indicated or founded report of child abuse or as an individual responsible for the injury or abuse in a founded or indicated report for a school employee.

I understand that my employment may be terminated if I have been convicted of a felony offense or have been convicted of a crime involving child abuse, child neglect, physical violence or moral corruptness.

Notwithstanding the designation of offenses for which state law prohibits hiring or requires dismissal, I understand that La Salle University reserves the right to make hiring, employment, discipline, or termination decisions based upon arrests or convictions of other criminal offenses. Except as required by law, a prior arrest or conviction of a crime shall not automatically disqualify a person from being hired or continuing employment. Any decision not to hire an applicant or to take employment action with respect to a current employee because of a past arrest or conviction for a criminal offense shall be made in a non-discriminatory manner and in accordance with La Salle University's Policy on Harassment and Non-Discrimination and all applicable legal requirements.

I hereby swear/affirm that the information as set forth above is true and correct. I understand that the penalty for false swearing is a misdemeanor of the third degree pursuant to Section 4903(b) of the Criminal Code.

Additionally, by signing below, I authorize La Salle University to conduct a credential and degree verification. I authorize La Salle University to use the information and reports it obtains for any lawful employment purpose including in connection with decisions relating to my employment.
